2. Location, Venue and Course

Competition will take place in town called **Sindi**. Sindi is located on the left bank of Pärnu River.

Sindi rapid:

Length – about 200 m

Width – about 25 m

Drop – 1,6 m

Difficulty – Class 2/3

Water flow – natural and may alternate between 14 to 400 m³

3. Events and Competition Program

There will be two races – one on August 14th and second on August 15th.

Individual events:

Saturday: MK1, WK1, MC1, WC1. 2 qualifications runs, best of two counts. One final.

Sunday: MK1, WK1, MC1, WC1, XC2. 2 qualifications runs, best of two counts. No final.

Team event:

Sunday: 3xMC1, 3xWC1, 3xWK1, 3xMK1. One run.

Following age groups will be awarded: U10, U12, U14, U16, U18, Open, 35+, etc.

The organizer reserves the right to change age groups if there are 5 or less athletes in an age group.

4. Entries and Participation Fee

Entries will be open from July 29th till August 12th, 2021.

Entry fee when registering until August 5th, 23:59 o'clock: 15 EUR one boat category per day. Entry fee when registering from August 6th, 2021: 20 EUR one boat category per day

5. Athletes/Teams Services

Participation fee includes:

- Access to the course
- one race in one category
- toilets
- Emergency first aid during the races.
- Place where club/nation can set up a tent
- team parking
- electricity for boat repairs

Sindi rapid venue does not have service building yet – it means there are no showers.

Accommodation is not included.

Other services:

*Some food providers will be operating on the venue during the race days or there will be possible to order a lunch box.

*Closest food stores is about 800 m from the venue (Sindi Konsum and Sindi Maxima).

* Closest restaurant (Kohvik Julius) is about 1,1 km

7. Visa Requirements

Estonia is a State-member of the European Union. The Estonian Embassy in your country will provide you with all details information about visas. Estonian Canoeing Federation can help with support letters or invitations for applying Visa.

8. Ticketing

Competition is free for the spectators. Entrance to the Venue could be limited or prohibited depending on Covid-19 restrictions.

9. Medical services

Organizers will provide and cover medical services only for emergency cases (first aid and ambulance). All participants are responsible to arrange, at their cost, their own medical insurance policy.

10. Health and Sanitary Covid-19 Measures

There is a high chance that non-vaccinated team members and spectators need to present a valid PCR test (not older than 72 hours). The organizers will publish specific Covid-19 rules once they are available.

The attending Clubs will remain responsible for their accommodation and travel costs in case of force majeure leading to a late cancellation of the competitions. Entry fees will be reimbursed in case the event is cancelled.

11. Safety Rules

During competitions each athlete must wear a safety helmet with a strap fastened under the chin and a buoyancy jacket. Both must be in good working conditions. The structure, shape or composition of the buoyancy jacket/helmet must not be modified in any way.

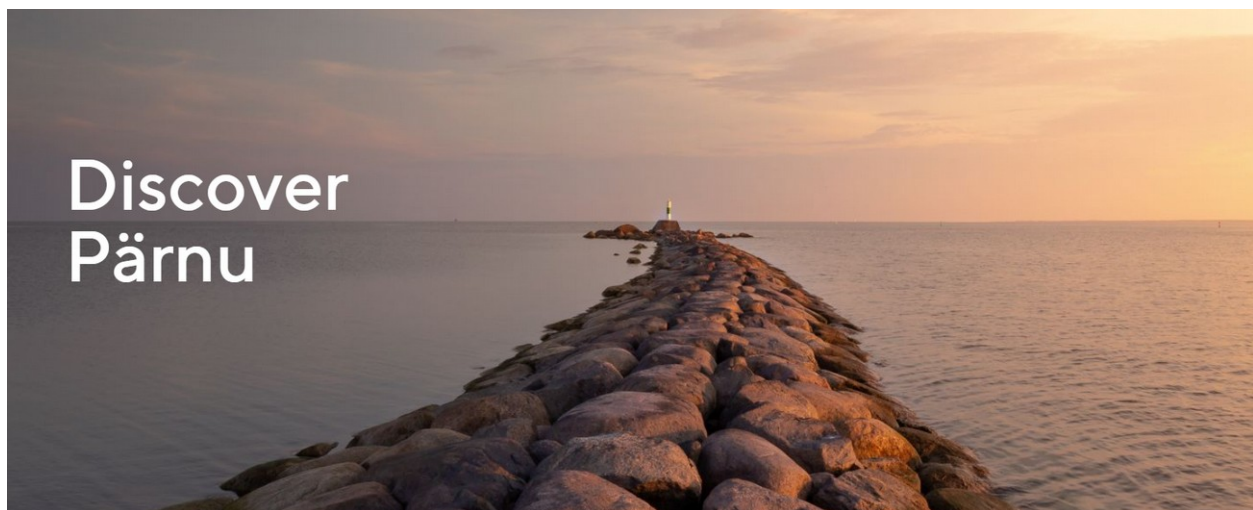
